**Housing expenses** refer to all housing-related costs, including rent for a dwelling or site, maintenance and capital expenditure charges, property taxes, heating costs and electricity and water charges.

**Vehicle and travel expenses** refer to all costs related to vehicles and travel incurred by the household, including vehicle maintenance costs, fuels, vehicle insurance and taxes, public transport costs and tickets.

**Expenses relating to groceries and convenience goods** refer to the household's food and grocery costs, including eating out.

**Child day care and maintenance expenses** refer to costs related to day care and other child maintenance.

**Expenses for leisure time and hobbies** refer to all expenses related to free time and hobbies incurred by the household, including tickets to the cinema, theatre and cultural events, equipment needed for hobbies, participation fees for leisure activities or holiday travel.

Clothing and footwear expenses refer to all clothing and footwear purchases of the household.

**Health and beauty care expenses** refer to all costs related to health and beauty care, including medical and health care fees, medicines, beauty care products and services or a barber's or hairdresser's services.

**Insurance expenses** refer to all insurance expenses of the household, excluding vehicle insurance, which should be included in Vehicle and travel expenses.

**TV**, **telephone and internet expenses** refer to all household expenses incurred from telecommunications and telephone subscriptions.

**Other expenses** cover all expenses not included in any other category, such as streaming services and newspaper and magazine subscriptions.
